**0.2. Executive Summary**: Project Management Unit (PMU), Global Partnership for Education-Balochistan Education Project (GPE-BEP) is implementing a three year project under the supervision of World Bank. The PMU has identified and notified all 725 locations for new primary schools and all 95 primary schools to middle and 25 middle schools to high level for up-gradation with set notified criteria. 1082 teachers have been recruited and deployed for 576 newly established and upgradation schools. Recruitment of teachers for the remaining schools is expected in first two quarters of the following year.

997 total teachers have been trained in the reporting year. However, PMU is committed to complete the training of all the target 1988 teachers by the end of first quarter of the following year.i.e. Jan-March, 2018.

In the reporting period year, K-5 total 37540 students' enrollment has been reported against 389 new primary schools established, and 118 (93 Middle and 25 High) under establishment up-gradation schools. This enrolment achieves 89% of project total enrolment target where 336 more new schools enrollment is yet to be reported. It is encouraging that PMU expects 17808 more enrolment from the remaining 336 schools at average of 53 enrolment per currently established each school average. This expected enrolment will achieve project enrolment target above 100%.

Furthermore, 787 total schools have been advertised for construction works. Contracts have been awarded to start works in 709 schools. Whereas, works have been started in 570 schools.

ECE TLM material has been procured for 365 schools which will be distributed in all 845 schools and will not be procured any further, a taaleemi basta and multi-grade bags have been procured for all the 845 schools instead. In the reporting period, 165 schools have been provided with the TLM kits.

231 schools have been provided with the furniture including blackboard. ECE Program has been established in 507 schools including 389 newly established schools and 118 upgraded schools.

**0.3. Project Background:** The Government of Balochistan, Education Department is implementing a project titled "Global Partnership for Education-Balochistan Education Project" (GPE-BEP). The development objective of the proposed three years' project is to increase enrollment and retention in project supported schools, with special focus on girls' participation, and to develop mechanisms to improve quality of education and school management. The three major components of this project are:

#### 1. Access and Equity:

- a. Establishment of 725 new primary schools (Mixed Gender) with provision of early childhood education and involvement of community
- b. Up-gradation of 120 schools (95 Primary to middle schools and 25 middle to higher secondary)

#### 2. Quality and increased accountability:

a. Promoting Early Childhood Education through teachers training and teaching learning material.

b. School information collection, dissemination and use for improved planning and decision/Real Time School Monitoring system


#### 3. Technical Assistance for improved Capacity for Management and Monitoring:

- a. Teacher development through provision of Teaching and Learning Material (TLM).
- b. Student Assessment and Real Time School Monitoring
- c. School Information Management System

## **Results based progress**


#### 1. Project Development Objectives

PMU M&E Section plans, coordinates, collects, verifies, consolidates, analyses and disseminates all the progress against the Result Framework indicators on quarterly basis. The M&E Section conducts field monitoring visits, evidences and data audits, tracks and follows up the removal of the variance/discrepancies in the data for smooth record, reporting, improved actions and management. Following is the snapshot of BEP MIS Dashboard which is the main source of reporting under the project. This source only excludes data of 2.6 which was not updated on dashboard so far.



#### 1.1 Girls enrolled in grades K-5 of project supported government schools


**Progress:** The enrollment of 27802 in the bar chart is the result of the restless effort of all the PMU program sections. The enrolment/schools increased to 27802 in 507 schools in the reporting period at ratio of 104% of the total project enrolment target which is highly commendable. The 507 schools given in the bar include the enrolment of 389 newly established and 118 upgradation schools for the reporting period. The K-5 girls enrolment has been achieved over



100% where 336 schools enrollment are still to be included.

The remaining 336 schools at this average of 30 per school (when established) will add 10080 more enrolment which will sum the total enrolment as 37882. And this clearly projects that the achievement against this target indicator will be 142% which surpluses 42% of the girls K-5 enrolment to be highly satisfactory.


- *Lesson(s) learned:* While selecting the schools, maximum enrollment-potential locations should be selected.



- *Recommendation(s):* The Education Section should randomly validate the enrollment of at least 25% reported schools. The enrolment should be validated and mobilized to be retained at schools. The TLMs and other materials and the schools buildings should be provided/completed as soon as possible to avoid the dropout.

#### 1.2 Boys enrolled in grades K-5 of project supported government schools


*Progress:* The enrollment of 9738 in the bar chart is the result of the restless effort of all the PMU sections. The enrolment/schools increased to 9738 in 507 schools in the reporting period at ratio of 63% of the total project enrolment target. The 507 schools given in the bar include the enrolment of 389 newly established and 118 upgradation schools for the reporting period. The K-5 boys enrolment achieved so far projects that the remaining 336 schools at



this average of 23 per school (when established) will add 7728 more enrolment which will sum the total enrolment as 17466. And this clearly projects that the achievement against this target indicator will be 113% which surpluses 13% of the boys K-5 enrolment to be highly satisfactory.


- Lesson(s) learned: While selecting the schools, maximum enrollment-potential locations should be selected.

 Recommendation(s): The Education Officers should randomly validate the enrollment of at least 25% reported schools. The enrolment should be validated and mobilized to be retained at schools. The TLMs and other materials and the schools buildings should be provided/completed as soon as possible to avoid the dropout.



#### 1.3. Girls enrolled in grades 6-10 of project supported government schools

- **Progress:** The enrollment of 6-10 girls in the reporting year is 2051 in 118 schools which is 111% of the set target. This project indicator has been achieved over 100% which is highly satisfactory. The enrollment of girls 6-10 is achieved from project supported upgradation schools. However, the construction works completion, provision of material and teachers arranged for upgraded schools is under process. The upgraded schools have entirely been selected on available higher enrolment and higher potential enrolment for the upgraded levels.




- *Lesson(s) learned:* The schools with high enrolment and feeder schools should be selected for up-gradation.
- *Recommendation(s):* The Education Officers should randomly validate the enrollment of at least 25% reported schools. The enrolment should be validated and mobilized to be retained at schools. The TLMs and other materials and the schools buildings should be provided/completed as soon as possible to avoid the dropout.

#### 2.0. Intermediate Results

#### 2.1. Number of new primary schools established through community support

• **Progress:** The chart shows that 389 of 725 schools have been established. The chart shows that the schools establishment ratio has comparatively been well improved to the reporting period as 54%. 1070 teachers have been hired by the reporting period for 513 primary schools which is satisfactorily improved by the reporting period. It is expected that all the due number of the


teachers will be completed by the end of the project.



- *Lessons learned:* The PMU should ensure that all the concerned UCs villages have received the information in regard to applying for the concerned schools. Few of the concerned UCs schools did not apply for the NTS tests.
- *Recommendation(s):* Through all the available means, PMU must ensure that the concerned villages receive the information in regard to schools for applying NTS tests.


#### 2.2. Number of schools upgraded from primary to middle level

Activity Updates: PMU has completed all the homework to proceed with the activities against this indicator. There is target of 95 middle schools upgradation from the Primary level in the project. All the 95 schools have been identified and notified. PMU has started working on upgradation activities in 99% of the upgraded schools. It is reported that 47 of 93 middle schools have started studied in class 6.




#### 2.3. Number of schools upgraded from middle to high/higher secondary level

Activity Updates: PMU has completed all the homework to proceed with the activities against this indicator. There is target of 25 high schools upgradation from the Middle level in the project. All 25 schools have been identified and notified. PMU has started working on upgradation activities in 96% of the upgraded schools. It is reported that 8 of 25 High schools have started studied in class 9.




## 2.4. Number of government schools to which furniture (incl blackboard) is provided

Activity Updates: The procurement of all the target schools have been made. PMU has provided 231 of 845 schools with the furniture including blackboard in the reporting period. However, PMU has planned to provide all the schools with furniture including blackboard by the end of the project.



#### 2.0.2. Project Total Schools Construction Works Progress Status


The chart shows that the construction works have been started in 579 (67%) of the total target of 845. However, the development team is committed to start and complete all the construction works of the schools by the end of the project period. The project construction works face seasonal break in summer and winter both the zones of the province of Balochistan.



#### 2.5. Number of schools to which TLM kits provided

*Activity Updates:* All ECE TLM 365 Kits have been procured which will be distributed among all 845 schools and will not be procured any further, a taaleemi basta and multi-grade bags have been procured for all the 845 schools instead.


The chart reports that PMU has provided 165 of 845 schools TLM kits so far. However, it plans to provide 300+ schools with the TLM kits in the coming quarter.



#### 2.6. Number of government schools in which ECE program established


Activity Updates: 338 of 845 schools are established with the ECE program under the project. The number is expected

increase in the coming quarter. Due to split items procurement and wise spread field, the ECE materials took time this quarter. However, the PMU has improved the supply and distribution plan and will expedite the supply and distribution in a much improved manned with increased number in the coming quarter.




#### 2.7. Number of PTSMC members trained in targeted project schools

Activity Updates: The number of the PTSMC memerbs has been improved as compare to previous quarter. 1124/25% of 4465/100% PTSMC members have been trained in the reporting period. The trainings are going on. PMU expects to have much more improved number in the coming quarter.



#### 2.8. Number of teaching staff trained in the project specific schools




Activity Updates: The pie chart shows that 997 of

total target teachers have been reported trained so far. This proportionate to have achieved 50% of the total project target so far.


PMU has planned more trainings in first and second quarters of the following year and will train all the remaining teachers. The progress is improved over the quarters .i.e. Jan-March, and April to June, 2018. Moreover, following other training modules were developed through experienced individual consultants:

- SST training module on pedagogy and content areas of Math, Science and English
- Head Teacher Training Module

#### 2.8.1. ECE Teachers Pre-Post Training Self-Assessment Analysis



A sample of 107 teachers in all 32 districts was taken for the Pre-Post ECE teachers training selfassessment. The chart shows 20% improvement in teachers learning. Whereas, the teachers training self-assessment scope of work determined at least 15% improvement in teachers learning.



#### Second Cycle Training of 630 ECE Teachers

A sample of 110 teachers in all 32 districts was taken for the Pre-Post ECE teachers training self-assessment test. The chart shows 24% improvement in teachers learning. Whereas, the teachers training self-assessment scope of work determined at least 15% improvement in teachers learning.

BEP trained a total of 997 school teachers in ECE across 32 districts of Balochistan so far. Given the challenges related to the context, quantitative data has been gathered from a representative sample of teachers. The sample size for this study has been determined using the following equation:





#### **3.7.2.** Successful implementation of Bio Matric Attendances:

As we all know the "Ghost Teachers" concept had given Education Department a long set back throughout the years, but BEP ensured that the teachers are punctual and regular on the responsibility on their shoulders. BEP issued Bio Matric Devices to recruited teachers so that they could easily mark their attendances at school and that ease on the other hand is quickest and convenient way for monitoring the attendance. So far, the Biometric is installed in 197 schools where 336 teachers are registered and these teachers were trained too.






The registration was done in presence of the concerned Education Officers of the region. Teachers can sign in and sign out only once in a day, the device does not allow multiple Entries. Teachers can use the device both offline and online mode, however to report their monthly attendance, they need to upload it through online system. The uploaded attendance record can be seen on MIS system automatically after the system is in-place.


#### **3.7.3. BEP Commitment to Provide Access to Remotest Areas:**

#### 3.1.4. Identification of Schools for EU Balcochistan Education Support project:

An individual Consultant was hired. He identified potential 150 clusters comprising 450 schools using Algorithmic formula considering following criteria based on the project objective:



These 150 clusters and 450 schools will further be scrutinized with field validation and physical verification into final 100 clusters and 300 schools which include 100 potential schools, 100 next level schools (High schools) and 100 feeder schools for the EU project of 100 Schools upgradation and 1000 rooms functionalization.

*CRC/General Complaints include all the complaints submitted to confirm schools selection, NTS tests, and Teachers selection. Since CRC-Complaint Redress Cell is chaired by concerned division honorable Commissioner at Division level, PMU does not have any mandate to redress the cases falling under the CRC level specifically in regard to teachers selection. However, PMU GRM-PAC receives the complaints and guides the complainants to move to the CRC to file their complaint.

#### 5. ESMP Annual Progress Report, 2017

#### 5.1. Environment and Social Management Plan (ESMP) Highlights

*Training Workshop:* Throughout the year, the main concertation was on broader application of ESMP checklist and guidelines. Contractors, Site engineers, SDEs and Field Supervisors were all apprised on ESMP checklists through a training workshop. Data collection of ESMP checklists is an ongoing process and the data of site selection checklists has not only been



collected but much of it has also been entered on Project MIS.

Based on the issues reflected in ESMP siting stage checklists, the remedial actions were proposed in line with the guidelines of environment and social





safeguard. Some of the issues related to siting stage have been resolved but on the other hand, construction related interventions on different site are underway.

*Plantation:* Plantation has been made an integral part of all the project focused schools. However, due to non-availability of water in many districts, less

tress are being planted. School students have also been involved in plantation merely to develop a sense of ownership and care for the plants.

*Water conservation:* A session on water conservation at household level was carried out with school students. The purpose of this session was to make school students realize the importance of world for human beings and for the earth as a whole. During the session, students came up with the ideas as how can they save water while performing different household activities.

*Health Screening:* Health screening in different project focused schools is carried out to identify the health related problems of students in project focused schools. These sessions are carried out by the staff of People's Primary Health Initiative (PPHI) that is comprised of health specialists. Besides health screening, session on WASH is also carried out by the staff of PPHI in project focused schools. These sessions help children learn the importance of personal hygiene and keeping their surroundings clean.
