#### 1.0. **Project Introduction**:

Balochistan is the province with the largest territory, but with lowest economic indicators and lowest Human Capital Index (HCI) score of 0.34. The HCI score is even lower for women (0.32). This low score in HCI is partially linked to Balochistan's alarmingly high (42 percent) poverty rate and prevailing sociocultural norms which hinder the utilization of health and education services in the province.

Delivery of both health and education services in Balochistan has been further affected by the inflow of Afghan refugees, as the province has been hosting Afghan refugees for over 40 years. According to UNCHR, while most have now been repatriated, there are still around 325,000 registered Afghan refugees residing in different districts of the province, including Quetta, Pishin, Chagi, Killa Saifullah, Loralai, and Killa Abdullah. The presence of large number of refugees without commensurate increase in resources has put extra pressure on the already stretched social sectors, severely affecting access to and quality of health and education services for both host communities and refugees.

The Government of Balochistan (GoB) is implementing the 'Balochistan Human Capital Investment Project' (BHCIP) with the assistance of the World Bank to improve the utilization of quality health and education services in selected refugee hosting districts of Balochistan, by investing to fill supply and demand side gaps and strengthening service delivery systems through improved management and governance. It is expected that BHCIP will provide impetus to generating significant social and economic returns in the long term through a more educated and healthy population. The project will pay special attention to: (a) gender equity; (b) quality of services; and (c) synergies between health and education interventions to maximize accumulation of human capital.

#### 2.0. Project Activities Conducted During the Reporting Quarter

#### 2.1. Hiring of EDS&QA firm completed:

The Engineering Design, Supervision, and Quality Assurance (EDS&QA) Firm hiring completed on 17<sup>th</sup> August, 2022 for the execution of construction activity in the field during the period. The firm will further be trained and deployed in the field to conduct the Technical Assessment survey for the development of the school master plans and BoQs for hiring of the contractors.

#### 2.2. Orientation of the EDS&QA firm:

Orientation session was conducted for the EDS&QA firm staff on 31<sup>st</sup> August, 2022 in the following week of the agreement signed between the EDS&QA Firm and the PMU. The orientation session included detailed review of the technical assessment tools and the data collection ethics in the community. The mock exercise was also conducted in training session and the tool was tested in the nearby schools.

#### 2.3. Technical Assessment Data Collection activity in 294 project schools:

The technical assessment and data collection activity started in the first week of September 2022, starting from the flood affected schools. The rest of the schools were decided to be proceeded once the flood affected schools assessment is completed for immediate rehabilitation as emergency response. The activity is under process and is planned to be completed in the first week of November, 2022.

#### 2.4. Technical Assessment Data Uploaded on Project MIS WEB Portal:

The technical assessment data is collected from field on hard tools and then uploaded via web portal on the project MIS dashboard. The data is being uploaded on the dashboard alongside the data collection from the target schools. This data will help the PMU to make analysis of the schools data for the development of the civil works master plans and BoQs for hiring of the Contractors. This activity is under process and is expected to end by third week of the November, 2022. The data is synced on the dashboard after its verification by the Schools Development Engineers (SDEs) of the PMU.

# 2.5. Project Coordination Committee (PCC) and Project Steering Committee Meetings Conducted:

Project Coordination Committee is mandatory body to monitor the project activities. The PCC is chaired by the honorable Secretary School Education Department of Balochistan and PSC is an oversight/approval committee and chaired by Additional Chief Secretary (Dev). The PCC reviewed the budget and proposed the re-appropriation to the PSC for approval. PSC, on the basis of the PCC recommendation, market rate analysis, review of scheduled/non-scheduled items approved the proposal of the PCC. The proposal included the rates of the solarization items, IT lab items, Science lab equipment and EMIS Cells equipment. PCC also directed PMU to conduct a DEOs meeting to discuss project interventions and share list of the schools to avoid duplication of BHCIP activities with those of the SED regular clusters budget.

#### 2.6. Project Technical Committee Meeting Conducted:

The alignment and integration of the education activities was discussed in the Technical Committee Meeting. The committee was apprised with the project activities in regard to the students' assessment improvement in the schools and in the policy along with the training of BAEC and development of associated material. The teachers training activity was discussed with the PITE and the improvement in the PITE Policy and capacity building was discussed.

# 2.7. Identification of Flood Affected Schools and meetings with the affected communities:

The provincial data for the flood affected schools was analyzed and 46 schools were found affected in the project target schools. Of these 46 schools attached as **Annex-A**, two schools were found to required emergency response. These two schools' technical assessment would be conducted immediately in the coming month for starting of the civil works as emergency response.

Simultaneously, as a process of the civil works activity, the meetings were conducted with the local community of the affected schools to seek their idea and acquirement of the land when needed. However, the additional land was not needed and the community was taken on board to support the civil works in the community.

#### 2.8. Development of Technical Assessment Web Portal Project MIS Dashboard:

In consultation with the WB Engineer and PMU Civil Works Section, the tool for the technical assessment was finalized for the technical assessment data collection. The objective of the data collection is to assess the needs of the schools in regard to establishment of new classrooms, toilets, boundary walls and rehabilitation of the existing classrooms, toilets, boundary walls including assessment of the availability of the WASH facilities, Electricity, Gas, and water facilities in the target schools. Based on the technical assessment data collection tool, the IT individual consultant developed the MIS Web Portal for the technical assessment data entry for further necessary analysis.

#### 2.9. Development of Community Mobilization Firm ToRs:

Community Mobilization Firm ToRs were developed and shared with the WB for the technical review and feedback. The ToRs are yet to be finalized and under review.

#### 2.10. Project ESMP Activities Update:

Environment and Social Safeguard Management and Monitoring Checklist (Siting Stage) checklist has been digitized. This process will convert the collected information into a digital format and will make the collected data available on the project dashboard.

Digitization of data will be helpful for further analysis and preparation of the site-specific Environment and Social Management Plan (ESMP).

Orientation of EDS&QA staff on ESMF tools has been arranged. The purpose of this orientation was to make the staff aware of environmental and social safeguard guidelines and their importance for any project. All the world bank guidelines were explained to the EDS&QA staff. Moreover, a detail session on the ESMF related tools also took place for developing the better understanding of EDS&QA staff on the said tools.

Pilot testing of ESMF-related tools was also carried out. The EDS&QA staff filled all the ESMF-related documents in the field and their queries were addressed during the pilot testing. The purpose of piloting testing was to get error free data from the field. After pilot testing of ESMF-related tools, the staff of EDS&QA staff left for the filed visit to collect data of E&S screening baseline checklist.

Installation of solar panels leads towards a healthier environment and cleaner air through the reduction of greenhouse gas emissions and air pollution and ensure the availability of electricity in the schools. In accordance with the numerous advantages of installation of solar panel, PMU decided to opt this technology for its 57 high schools. For the safe installation of solar panel and more importantly to ensure the safety of school students SOPs and Environmental and social screening checklist has been prepared. The screening checklist of Solarisation has been shared with the bank. The comments of bank were addressed and the approval of this checklist has also been received from the bank. In addition to above the SOPs for the installation of solar panel have also been prepared and will be shared with the bank through this report.

Guidelines for construction work and construction vehicles have been prepared. These guidelines will provide information to contractor on the likely impact of construction activities on the environment and from the social side. These guidelines will help contractor avoid and minimize environmental and social impact and to undertake appropriate remedial measures.

The most common risks associated with flooding is the contamination of drinking-water facilities, and standing water, which can be a breeding site for mosquitoes, bring chemical hazards, and cause injuries. waterborne diseases. Keeping in mind the prevailing situation, PMU has prepared an awareness raising material to protect the flood affectees from being pray of waterborne diseases. The literature is comprised of water purification methods at household level and waterborne diseases. This literature will be distributed in the project-focused districts. It will help the flood affectees know the risk associated with the drinking of unclean water and will guide them towards the right path to protect themselves from water borne diseases.
